

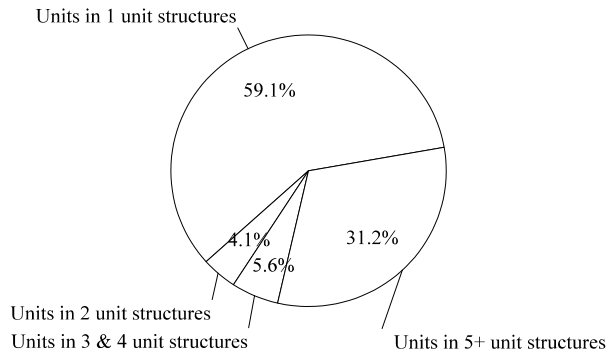
North Dakota Housing Units Authorized by Building Permits: 2000

North Dakota had 2,130 housing units authorized by building permits for construction in 2000. Of these newly-authorized housing units, 1,259 or nearly 60 percent were single-family homes or 1-unit structures (the 2nd lowest proportion in the nation) while 871 or 41 percent were in multiple-unit structures.

The data provided in this publication (new privately-owned residential housing units authorized by building permits) are obtained by the Census Bureau from permit-issuing jurisdictions (municipalities, counties, townships, unincorporated towns) on a monthly basis. County level data are totals provided for each county in which every permit office is requested to report monthly.

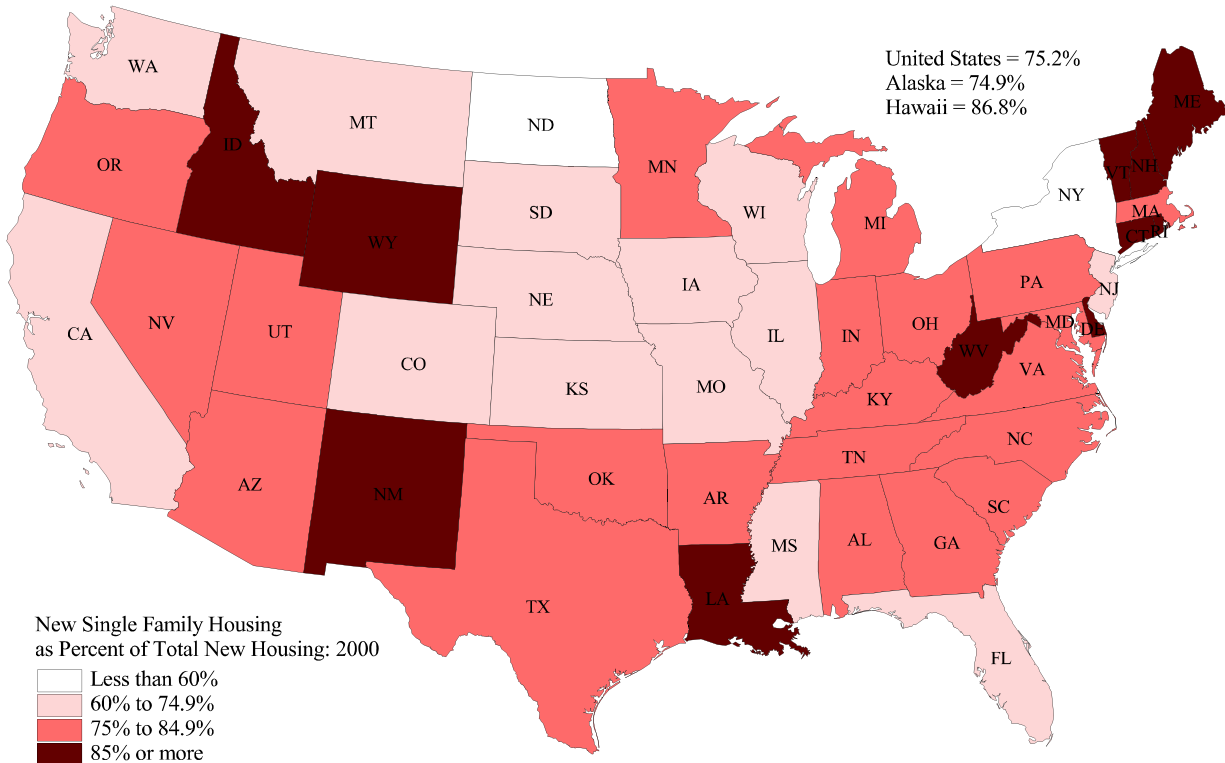
Distribution of Newly Authorized Housing Units by Type of Structure, North Dakota: 2000
