

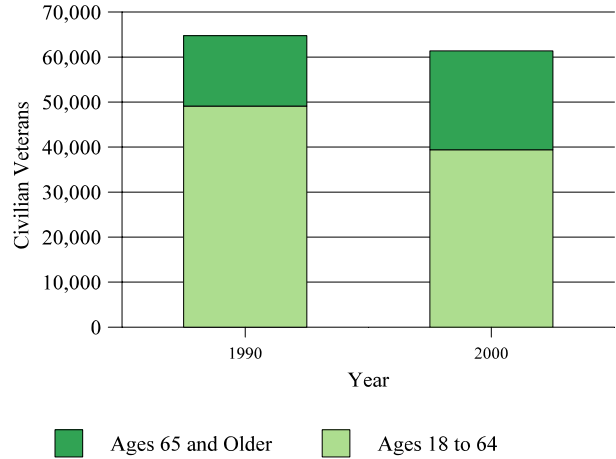
Civilian Veteran Status in North Dakota: 2000

In 2000, civilian veterans in North Dakota totaled 64,772 or 12.7 percent of persons 18 years and older, a slight decline from 14 percent in 1990. This decline is largely due to a loss of World War II veterans. In 1990, veterans of WWII who did not participate in the Korean conflict nor Vietnam totaled 18,591. This number dropped to 11,604 in 2000, a 38 percent decline.

While the overall number of veterans has declined, the age and gender distribution of North Dakota veterans has changed substantially over that last ten years. Persons 65 and older now comprise more than one-third of all North Dakota veterans (35.8 percent). This proportion rose from slightly less than one-fourth in 1990 (24.2 percent). Female veterans, while comprising less than six percent of all veterans in 2000, increased 27 percent since 1990 to reach 3,470.

Civilian Veterans 18 Years and Older by Age

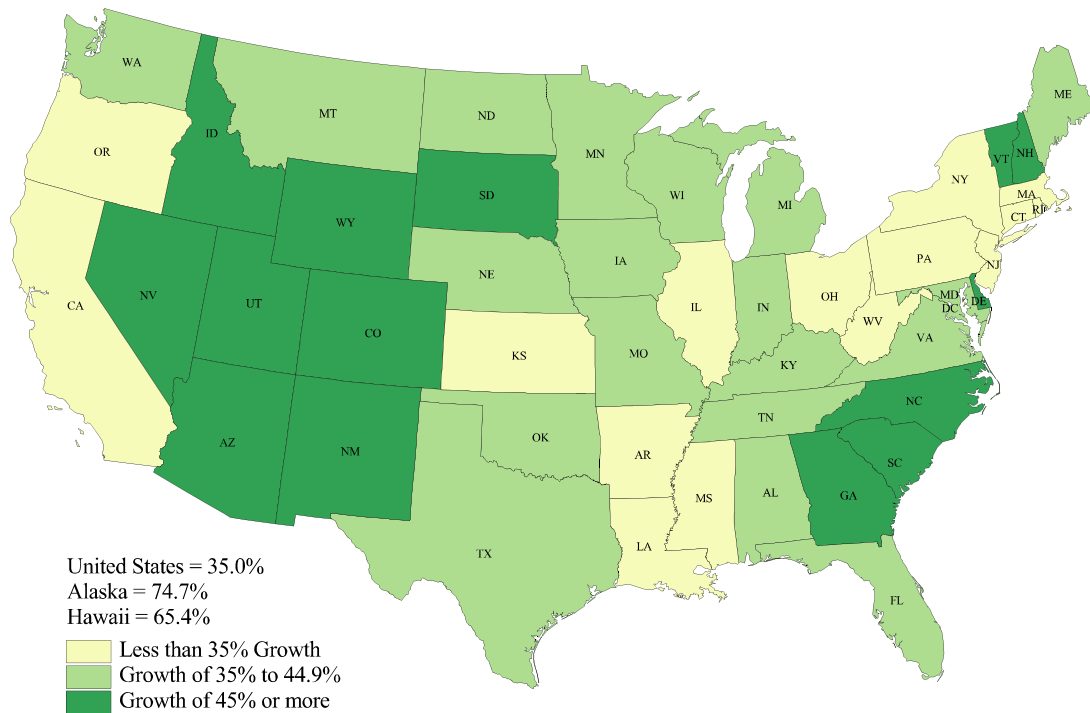
North Dakota: 1990 and 2000
