

## Business Establishments, Employees, and Annual Payroll in North Dakota: 2002

Between 2001 and 2002, the number of business establishments in North Dakota rose 1.1 percent, from 20,206 to 20,422. Private-sector employment for the state as of mid-March 2002 was 253,980, down 1.3 percent from 257,335 in mid-March 2001. Annual total payroll for the state was \$6.6 billion, up 1.8 percent from \$6.4 billion in 2001. This resulted in an annual payroll per employee of \$25,805 in 2002, up 3.2 percent from \$25,012 the year before (Table 1). Nationally, the annual payroll per employee averaged \$35,081 in 2002.

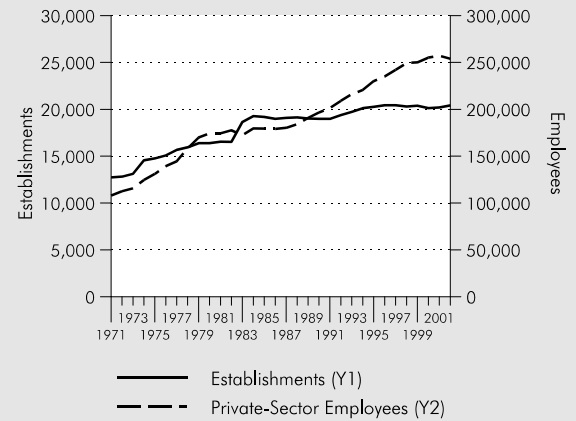
The number of business establishments in North Dakota has remained relatively stable over the past 10 years. In contrast, the number of private-sector employees rose consistently during this time (Figure 1).

The service industry continues to employ the largest portion of North Dakota's private-sector workforce at 43.7 percent in 2002, with an average annual payroll per employee of \$22,207.

Nevada, Florida, Utah and Idaho reported the largest percentage gains in businesses between 2001 and 2002 (5.2 percent, 3.6 percent, 3.4 percent, and 3.2 percent, respectively) (Figure 2). One state, Massachusetts, reported an overall loss in businesses during this time.

The businesses included in this bulletin are only those covered by the Federal Insurance Contributions Act (FICA). Self-employed persons, domestic service workers, railroad employees, agricultural production workers, and most government employees on ocean-borne vessels or in foreign countries are excluded.

Figure 1. Business Establishments and Private-Sector Employees in North Dakota: 1971 to 2002

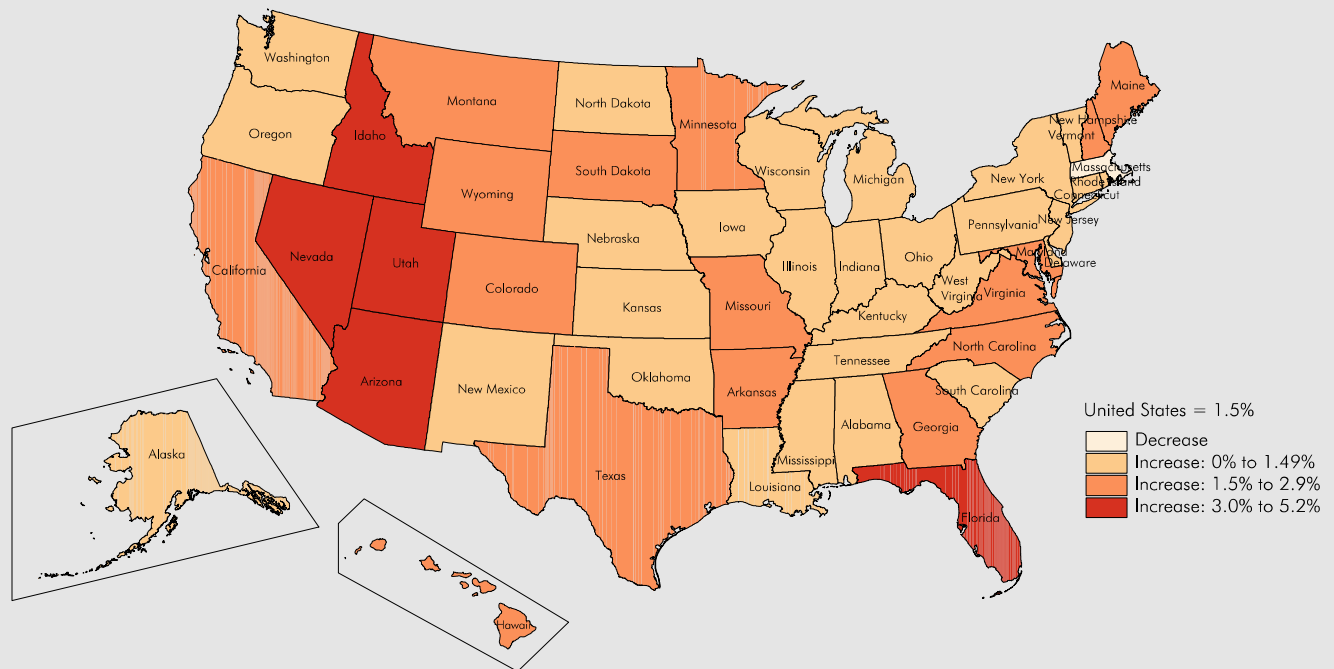
