

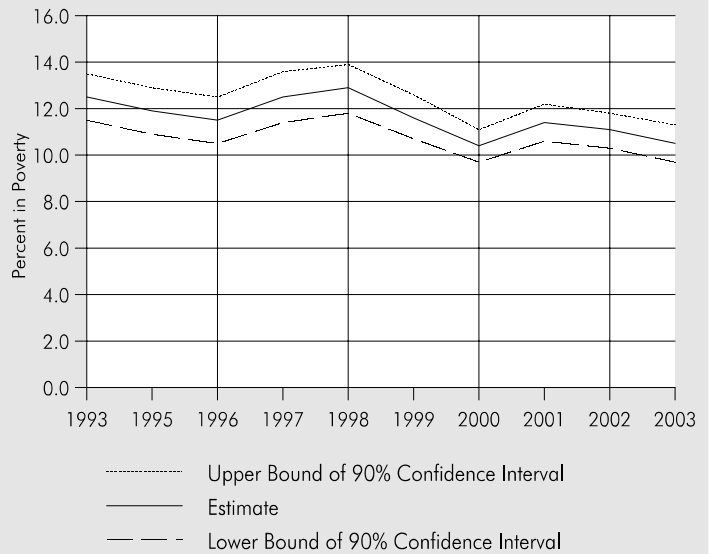
Poverty Estimates for Individuals in North Dakota: 2003

Approximately one in 10 North Dakotans were living in poverty in 2003, a rate down slightly from one in eight in 1993 (Figure 1). The Small Area Income and Poverty Estimates (SAIPE) program, which is part of the U.S. Census Bureau, provides annual estimates of the number and percentage of total persons and children living in poverty. These estimates are based on a sample of households. Due to the small population base in North Dakota and the need to keep costs of data collection manageable, the sample sizes for the state are relatively small, though this increases the likelihood of error. Therefore, confidence intervals are calculated to account for sampling error. For example, SAIPE estimates indicate that 10.5 percent of all North Dakotans were living in poverty in 2003. However, in order to be 90 percent confident of the true poverty level, one should use a range from 9.7 percent to 11.3 percent (Table 1).

Poverty rates in North Dakota were notably higher in reservation areas, with Sioux, Rolette, and Benson counties averaging one-in-four persons living in poverty in 2003. Areas in the south central and western parts of the state also had higher rates of poverty (Figure 2). However, when making important decisions based on these data, one needs to be mindful of the confidence intervals (Table 1).

Nationally, 12.5 percent of all persons were living in poverty in 2003 (the 90% confidence interval ranges from 12.2 percent to 12.7 percent) (Table 1).

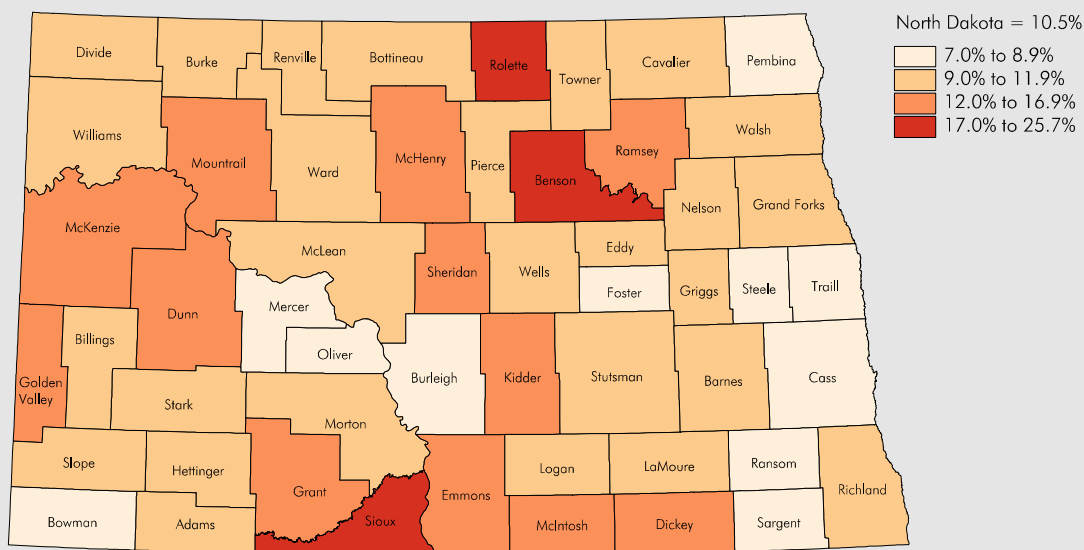
